

**Memorandum of Understanding  
Between  
Irish Embassy,  
Norwegian Ministry of Foreign Affairs  
And**

**The Department for International Development (DfID), United Kingdom of  
Great Britain and Northern Ireland**

**The Malawi Civil Society Governance Fund (CSGF) - Tilitonse**

1. I refer to the Memorandum of Understanding (MOU) for the above project signed by DFID and Irish Embassy, Norwegian Ministry of Foreign Affairs on 10<sup>th</sup> November 2011 and subsequently amended in November 2014 (Amendment No. 1 2014). Following recent correspondence, DFID propose to change the end date to October 2017 and increase the amount made available to DAI/HTSPE/Tilitonse by GBP 5,800,000.00 (five million eight hundred thousand pound sterling) to GBP 19,000,000 (nineteen million pound sterling).
2. I therefore propose that the end date of September 2015 in paragraph 2 of the original MoU be deleted and replaced by October 2017.
3. The Donors shall, subject to their respective appropriations and the terms and procedures of the MoU and this Addendum No 2. provide additional grants as follows:
  - MFA – not exceeding NOK 15,000,000.00 (Norwegian kroner fifteen million) to be used to support CSGG in the period 2015-2017. The total amount provided by MFA as stated in Clause 14 of the MoU shall be changed to 46,000,000 (Norwegian Kroner forty six million).
  - Embassy of Ireland – not exceeding EUR 400,000.00 (four hundred thousand euro) to be used exclusively to support CSGG in the period 2015-2017. The total amount provided by the Irish Embassy as stated in Clause 14 of the MoU shall be changed to EUR 2,550,000 (two million five hundred and fifty thousand euro).

- DFID – not exceeding GBP 4,000,000.00 (four million pound sterling) to be used exclusively to support CSGG in the period 2015-2017. The total amount provided by the DFID as stated in Clause 14 of the MoU shall be changed to GBP 13,617,858.00 (thirteen million six hundred and seventeen thousand eight hundred and fifty eight pound sterling).
4. This letter of amendment will place on record our common understanding of the above change and will come into operation on the date you sign your confirmation below. This note will be known as Amendment No. 2 2015.
