**MWI-12/0010: Agreement dated 14 November 2012 regarding Malawi College of Medicine, Research Project – Addendum Number 1 Grant Letter between the Norwegian Ministry of Foreign Affairs and the Government of the Republic of Malawi**

With reference to the Agreement between the Norwegian Ministry of Foreign Affairs (MFA) and the Government of the Republic of Malawi (Malawi) on development cooperation concerning the Malawi College of Medicine Research Project-Impact of Using Performance-Based Financing to Improve The Quality of Obstetric and Newborn Care in Malawi dated 14<sup>th</sup> May, 2012, as well as your request dated 2 June 2014, for additional Norwegian assistance to the Malawi College of Medicine Research Project, I have the honour of proposing the following for your consideration:

MFA shall, subject to Parliamentary appropriations and the terms and procedures of the Agreement and this Addendum, provide an addition to the Grant not exceeding NOK 1 470 000 (Norwegian Kroner one million four hundred and seventy thousand) in the planned period May 2013 to June 2016. **The first disbursement of an amount of NoK 670, 000 (exchange rate 6.1)** will be made upon signing of this agreement.

Subsequent payments will be made in accordance with the existing agreement, but will be contingent upon receiving a work-plan and budget covering the whole implementation period.


