

AMENDMENT NO.2
TO THE CONTRIBUTION AGREEMENT
BETWEEN

UNITED NATIONS ENTITY FOR GENDER EQUALITY AND THE EMPOWERMENT
OF WOMEN (UN-Women)

AND

THE NORWEGIAN MINISTRY OF FOREIGN AFFAIRS (MFA)

WHEREAS the United Nations Entity For Gender Equality and the Empowerment of Women (UN-Women) and the Norwegian Ministry of Foreign Affairs (MFA) has entered into a Cost Sharing Agreement dated 23/12/2013, as amended by addendum number one dated 04/12/2014 (hereinafter "Agreement"), concerning MWI-13/0026 UN-Women Gender and Agriculture Project (the Project),

WHEREAS UN-Women in letter dated 23/06/2015 has requested an extension of the Project period and additional financial assistance to the Project, with which MFA has decided to comply,

NOW THEREFORE the Parties have reached the following understanding, which shall constitute addendum number 2 to, and be an integral part of the Agreement.

Article I – Extension of the Support Period

The Support Period set forth in Article IV Clause 1 of the Agreement shall hereby be extended to 31/12/2015. The Parties agree that the period 30 June 2015 to the date of signature of this Addendum shall be deemed to be included in the Support Period.

Article II – Additional Grant

MFA shall on the terms and conditions of the Agreement, provide an additional grant not exceeding NOK 3 224 000 (Norwegian kroner three million two hundred and twenty four thousand) (the Additional Grant). Therefore, with the previous contributions of NOK 6 556 012, the total Contribution amount in Article IV Clause 1 of the Agreement shall be NOK 9 780 012.

The Additional Grant shall be used exclusively to finance the Project as specified in the revised budget and work plan included as Annex 1 to this Addendum during the Support Period, until 31/12/2015.

The Additional Grant shall be disbursed upon signing of this Addendum.

Article III – Final report

The final report (composed of narrative and financial report) and the certified financial statement mentioned in Article VI Clause 3 letters c) and e) respectively, shall be submitted by UN-Women no later than 30 June 2016.

Article IV – Remaining conditions of the Agreement



All other provisions of the Agreement shall remain unchanged and in force.


Article V - Entry into force and duration


