

AMENDMENT NO.3  
TO THE CONTRIBUTION AGREEMENT

BETWEEN

UNITED NATIONS ENTITY FOR GENDER EQUALITY AND THE EMPOWERMENT  
OF WOMEN (UN-Women)

AND

THE NORWEGIAN MINISTRY OF FOREIGN AFFAIRS (MFA)

**WHEREAS** the United Nations Entity For Gender Equality and the Empowerment of Women (UN-Women) and the Norwegian Ministry of Foreign Affairs (MFA) has entered into a Cost Sharing Agreement dated 23/12/2013, as amended by addendum number one dated 04/12/2014 (hereinafter "Agreement"), concerning MWI-13/0026 UN-Women Gender and Agriculture Project (the Project),

**WHEREAS** UN-Women in letter dated 23/06/2015 has requested an extension of the Project period and additional financial assistance to the Project, with which MFA has decided to comply,

**NOW THEREFORE** the Parties have reached the following understanding, which shall constitute addendum number 3 to, and be an integral part of the Agreement.

**Article I – Extension of the Support Period**

The Support Period set forth in Article IV Clause 1 of the Agreement shall hereby be extended to 31/03/2016. The Parties agree that the period 30 September 2016 to the date of signature of this Addendum shall be deemed to be included in the Support Period.

**Article II – Additional Grant**

MFA shall on the terms and conditions of the Agreement, provide an additional grant not exceeding NOK 3 224 000 (Norwegian kroner three million two hundred and twenty four thousand) (the Additional Grant). Therefore, with the previous contributions of NOK 6 556 012, the total Contribution amount in Article IV Clause 1 of the Agreement shall be NOK 9 780 012.

The Additional Grant shall be used exclusively to finance the Project as specified in the revised budget and work plan included as Annex I to this Addendum during the Support Period, until 31/03/2016.

The Additional Grant shall be disbursed upon signing of this Addendum.

**Article III – Final report**

The final report (composed of narrative and financial report) and the certified financial statement mentioned in Article VI Clause 3 letters c) and e) respectively, shall be submitted by UN-Women no later than 31 March, 2017. Moreover, a financial audit shall be submitted no later than 30 September, 2016.

All other provisions of the Agreement shall remain unchanged and in force.


**Article V – Entry into force and duration**


